Update

The IC2PerMed summarised version of the roadmap is now online

The **IC2PerMed Roadmap** represents the four years of commitment of the IC2PerMed project (2019-2023), involving seven European partners and three Chinese partners, and identifies common approaches to support research on personalised medicine at a global level. It represents the core central part of the project, sets out its description and vision: to promote collaboration between Europe and China for the development of personalised medicine and improve general access to its services

The IC2PerMed Roadmap also presents the working methodology of the project and its outcomes: the need to improve health literacy, the promotion of research, the building of public trust, the management of ethical challenges as well as the promotion of knowledge, of ethics, collaborations and policies in personalised medicine.

Workshops

3rd Sino-EU Permed webinar on PM perspectives in cancer and links with Traditional Chinese Medicine

The 3rd Sino-EU PerMed webinar, focused on personalised medicine perspectives in cancer with a special emphasis on Traditional Chinese Medicine, took place on 18 April 2023. This workshop, being the third of its kind, was a resounding success, bringing together a total of 64 participants - 22 onsite and 42 online. The webinar, held as a hybrid event during the Clover Leaf Tour, was hosted by the BioM biotech cluster in Munich. This collaborative effort between China and the Europe symbolizes the commitment to advance research and innovation in the field of personalised medicine.

Final joint webinar with ENRICH GLOBAL and PROPHET CSA project

The Second International Experts Forum & Policy Dialogue Workshop took place on 12 December 2023 from 11 am to 2 pm (CET). This online workshop, co-organised by IC2PerMed together with ENRICH GLOBAL's Health Innovation Thematic Group and the PROPHET project presented different perspectives, projects and initiatives in personalised medicine, personalised prevention, biobanking, and international collaboration.

The workshop has about 137 registrants and about 80 participants from 29 countries who were able to:

- exchange experiences and debate around the different PM approaches and how to better support evidence-based research, infrastructure development, coordination between research and policy, and international collaboration in PM.
- bring in the perspective of policy makers, researchers and innovators and possibly identify future topics of interest for international partners to be shared with the international PM initiatives, such as ICPPerMed and EP PerMed.

The purpose of the IC2Permed project is to foster improved development of PM policies, innovation and research, by bringing the EU and China's perspective on the field closer and more integrated.

The key word of the next steps of the IC2PerMed project is 'expertise': many experts in PM will be asked to share knowledge and opinions, in order to guarantee the best achievable approaches to the different topics. Their interaction will be promoted in the form of three multidisciplinary Working Groups (WG), handling the topics of 'Shaping sustainable healthcare' (WG1), 'Innovation and market' (WG2) and 'Research and clinical studies' (WG3).
